MY ROLE RESPONSIBILITY

The position of Business Continuity (BC) | Emergency Planner has responsibility for ensuring the WCDHB plans, exercises and maintains appropriate service continuity measures and is prepared to respond to and manage emergency situations when BC measures are overwhelmed.

Working alongside Canterbury based colleagues and with their support:

- Support the development and review of the Business Continuity plans (BCP's), defining goals, objectives and initiatives ensuring Ministry compliance.
- Identify and make recommendations for solutions to meet the needs of the organisation.
- Build awareness of Business Continuity methodology across the organisation.
- Develop and maintain health sector emergency response plans to ensure the WCDHB is capable of responding immediately and effectively to major incidents/emergencies in accordance with the requirements of the Ministry of Health Operational Framework and regional responses.
- Facilitate staff learning in the successful management of major internal/external emergencies and the WCDHB facilities, incorporating the Coordinated Incident Management and Health Emergency Management systems.
- Maintain the WCDHB EOC(s) for use in an Emergency.





- Manage the Emergency Operations Centre (EOC) when the WCDHB EOC is activated.
- Plan, conduct, and debrief regular mock exercises to test the adequacy of plans and strategies.
- Build and maintain strong relationships across the business and with key external stakeholders
